Vouchers - All vouchers must be cleared by the last day of the month.

Voucher take up to 5 days to clear funds these need to be cleared before the last day of the month.

Charges for absent

- Full fees are required when your child does not attend Kids' Corner due to illness, occasional days off or family holidays.
- 50% fee is required if the setting is shut down by the government for an emergency.

Additional notes for contracted hours if required

- Late Charges after 18.00 hours will be £20.00 per hour.
- Kids' Corner will not allow any extra hours on unpaid fees.
- Once hours are booked in the dairy, these cannot be changed or swapped as Kids' Corner has kept these spaces for you and so cannot fill it with another child.
- One months' notice needs to be given to change or end contracted hours.

Kids' Corner Limited agrees to:

1. Care for the child during the contracted hours and at such other times as may be mutually agreed.
2. Comply with all requirements of registration as laid down by the regulatory authority (Early Years Directorate, Ofsted) and the Care Standard Act.
3. Comply with all requirements laid down by the insurance company.
4. Notify the parent/guardian of any accident or injury occurring whilst the child is in the care of Kids' Corner Barlow Limited.
5. To provide the child with the following meals, such meals to be nutritionally balanced and prepared with due regard to the dietary, cultural and social requirements.
6. Maintain appropriate insurance cover, including public liability, and motor insurance.

The parent(s)/guardian(s) agree to:

1. Pay the fees set out overleaf on the day agreed.
2. Arrive and collect the child on time.
3. Provide the following item:
 - a) **Change of clothes**
 - b) **Sun cream**
 - c) **Coats**
 - d) **Wellies**
4. Give at least **4 weeks'** notice of cancellation of this contract.
5. Inform Kids' Corner Limited if the child has been ill within 24 hours before a contracted period and respect the settings' right to decide whether to accept a sick child for care.
6. Inform Kids' Corner Limited of any medicine prescribed by the child's doctor and given written permission for the setting to administer the medicine if such administration is required. Written permission will be required each time medicine is administered.
7. Notify Kids' Corner Barlow Limited at the beginning of each contracted period of any accident or injury the child may have suffered since last in the care of the setting, as the setting will record details.

Period of notice to end the contract is 4 Weeks

(Notice of termination of the contract must be given in writing, if 4 weeks isn't given charges will apply)
